I. LICENSURE, CERTIFICATION and REGISTRATION

LICENSURE BY EXAMINATION

Arizona is a member state of the Western Regional Examination Board (WREB). Graduates of accredited Dental and Dental Hygiene schools who have successfully passed the WREB examination within the last five years may apply for licensure by examination.

LICENSURE BY CREDENTIAL:

Applicants for licensure by credential may qualify in two ways:

- Successful completion of a Board approved clinical examination (other than WREB) within the last five years.
- Successful completion of a Board approved clinical examination taken more than five years ago and possession of a valid license in another state.

In either case, licensure by credential does not apply to graduates of non-accredited dental or dental hygiene schools.

CERTIFICATION

Denturist

Graduates from recognized denturist schools may apply for certification to practice denture technology in Arizona. During FY11, four applicants, who graduated from a recognized program; passed a Board approved examination received certification.

Dental Assistants

Radiography certification for dental assistants allows dental assistants to expose dental x-rays under the supervision of a dentist. At the December 3, 2010 meeting, the Board voted to approve the Dental Assisting National Board (DANB) Radiation Health and Safety (RHS) written examination. By approving the RHS, the Arizona specific clinical examination was eliminated. In FY11, successful certification was accomplished by one of three pathways.

- From July 1, 2010 through December 31, 2010 - Successful completion of a written and clinical x-ray examination. The Dental Assisting National Board (DANB) is the only nationally recognized organization that tests didactic and clinical competency of dental assistants for taking x-rays and continues to administer these examinations on behalf of the Board.

- From January 1, 2011 through June 30, 2011 – Success completion of the DANB RHS written examination. In addition to new applicants to take the RHS written examination, DANB researched their records to determine those dental assistants with Arizona addresses who had passed the RHS examination since January 1, 2006 and had not yet taken or had taken but not passed the Arizona specific Clinical Examination. DANB provided those individuals with an application for the Arizona Clinical Radiologic Proficiency certificate at no cost if they completed and submitted the certification form within three months of receiving the application.
- Dental assistants who have successfully completed a written and clinical examination prior to January 1, 2011 or successfully completed a written examination after January 1, 2011 other than DANB may complete an application for certification by credential along with evidence that certification was issued to them by a professional licensing agency in another jurisdiction.

Prior to June 1, 2011, coronal polishing certification for dental assistants was received upon successful completion of the Arizona Coronal Polishing Examination conducted by DANB and by submitting an Arizona Coronal Polishing Clinical Skills Affidavit, completed by a licensed dentist or coronal polishing educator/course instructor. At the April 1, 2011 the Board voted to approve DANB's National Coronal Polish Examination as the written portion of the certification process.

Dental practices offering dental services which are owned by individuals who are not licensed by the Dental Board are required to register. Registrations must be renewed on a triennial basis for a fee of \$100 per year.

PERMITS

The following permits are also issued by the Board:

Dental Hygienists may administer local anesthesia or nitrous oxide upon submission of evidence that they have completed Board approved course. Once the permit is issued by the Board it does not expire until the dental hygiene license lapses.

General Anesthesia: Dentists may induce general anesthesia by any means, or semi-conscious sedation by intravenous or intramuscular means on an outpatient basis by obtaining a Section 1301 Permit. These permits must be renewed every three years.

Conscious Sedation: Without a Section 1301 Permit, a dentist may induce conscious sedation by intravenous or intramuscular means on an outpatient basis by obtaining a Section 1302 permit which also expires every three years.

Oral Conscious Sedation: Unless a dentist holds a Section 1301 or 1302 permit they must obtain a Section 1303 permit before inducing oral conscious sedation on an outpatient basis and renew the permit every three years.

WESTERN REGIONAL EXAMINING BOARD (WREB)

The Board discontinued conducting clinical examinations for Dentistry and Dental Hygiene in 1978. Since that time, applicants for licensure by examination have been required to take and pass the WREB examination within the last five years.

WREB offers clinical examinations for dental, dental hygiene and dental hygiene local anesthesia throughout the country at dental and dental hygiene schools. Members of the Arizona State Board may serve as WREB examiners along with representatives of other state dental boards.

LICENSURE BY CREDENTIAL

Applicants for licensure by credential must submit evidence of successful completion of the clinical examination of another state or testing agency. In addition to WREB, clinical examinations are offered by the Central Regional Dental Testing Service (CRDTS), Southern Regional Testing Agency (SRTA); North East Regional Examining Board (NERB), and the Council of Interstate Testing Agencies (CITA). As with WREB, members of dental boards from throughout the country may serve as examiners for these agencies.

DENTAL ASSISTING NATIONAL BOARD (DANB)

RADIOGRAPHY: At the beginning of FY11, the Board's approved examinations for dental assistant certification in radiography included a specifically developed clinical examination conducted at dental hygiene schools. As of January 1, 2011, the Board approved examination became written only. The written RHA examination is offered at computerized testing services throughout the United States.

III. COMPLAINTS and INVESTIGATIONS

The Board is charged with investigating written complaints received as well as those filed by the Board on its own motion. Upon receipt of the complaint, the Investigative Team reviews the information provided, determines the appropriate allegations to be investigated, identifies to whom subpoenas should be issued and recommends which of the following investigation processes should be applied:

EXECUTIVE DIRECTOR TERMINATION

The Executive Director, with concurrence of the Investigative Staff may terminate a complaint if the Staff's review indicates the complaint is without merit and that termination is appropriate. The Executive Director provides a list of each complaint the Executive Director terminated at each regularly scheduled Board Meeting.

TERMINATION FOR LACK OF JURISDICTION

In cases where the allegations do not fall within the purview of the Board, the Chief Investigator may forward the complaint to the Board with a recommendation that it be terminated for lack of jurisdiction.

CLINICAL EVALUATION

Some cases involving quality of care may require an independent evaluation of the dental work in question by a Board approved Clinical Evaluator. The results of this evaluation are forwarded to the Investigative Interview panel and the Board for consideration.

INVESTIGATIVE OR INFORMAL INTERVIEW

An Informal or Investigative Interview (II) allows both the complainant and the licensee an opportunity to testify under oath before a panel of Board approved consultants including one or two licensees and a public member. In the case of an Informal Interview, the panel chair must be a Board member.

These interviews are audio recorded, a report is generated by staff summarizing the testimony and evidence presented, and includes the panel's recommended findings of fact, conclusions of law, and whether or not disciplinary action should be imposed.

BOARD MEETING

All panel recommendations are forwarded to the Board for final adjudication. Following a limited opportunity for additional testimony from the complainant or licensee, Board Members vote at an open meeting with all findings, investigative interview reports, x-rays, records, and materials available for review. The complainant and licensee as well as their representatives receive a copy of the Board final decision.

PETITION TO REHEAR

Licensees who are disciplined by the Board have the right to file a Petition to Rehear if they believe their rights were affected by the Board's decision or process. Upon review of the petition, the Board may vote to deny, grant an immediate rehearing or remand the case for further investigation. In the event the petition is denied, the licensee may file a Judicial Review Action in Superior Court.

IV. LICENSE SUSPENSION or REVOCATION

VOLUNTARY SURRENDER

Statute provides that a licensee may voluntarily surrender their license in lieu of further disciplinary action by the Board. The surrender is reported to the National Practitioner Databank (NPDB) as a disciplinary action to be considered by other jurisdictions prior to issuing a new license or by the Arizona Board before reinstating the license.

During FY11, one licensee voluntarily surrendered in lieu of further discipline. The Dental Hygienist chose not to participate in the two-year monitored substance abuse treatment program and voluntarily surrendered her license in lieu of disciplinary action.

VOLUNTARY SUSPENSION

The Board's Monitored Aftercare Treatment Program is designed to rehabilitate licensees who suffer from substance abuse and dependence. The terms of a standard Stipulation Agreement include:

- Successful completion of in-patient treatment – 30 day minimum
- 90 meetings in 90 days following release from treatment
- Five years probation
- Group Therapy
- Participation in the 12 step program including a sponsor
- Three Alcoholics/Narcotics Anonymous meetings per week
- Random Urinalysis
- Periodic meetings with the MATP Medical Director and Psychological Counselor
- If applicable Restriction of DEA privileges for a minimum of two years

Four dentists voluntarily surrendered their licenses in FY11 pending in-patient evaluation/treatment. All four of the licensees entered into MATP.

LICENSE REVOCATION

Between July 1, 2010 and June 30, 2011 the Board forwarded one case to Formal Hearing for possible license suspension or revocation.

Case 201000097 – The allegations in the case were non-compliance with private substance abuse monitoring and inability to safely practice dentistry. The respondent did not respond to the complaint and notice of intent to go to a formal hearing in the allotted 20 days. The Board voted to deem the allegations admitted, accepted the findings of fact and conclusions of law and revoked the license.

V. FINANCIAL TRANSACTIONS

Licensure, permit and penalty fees assessed to licensees are collected by the Dental Board. 90% of the funds collected are deposited into the Dental Board Fund and 10% are deposited into the State's General Fund. The Board is required to submit a biennial budget request to the Governor justifying all anticipated expenditures for a two-year period. The Legislature determines the annual appropriation amount for each year of the two year cycle. These amounts become the Board's operating budget. At the end of the cycle, unexpended funds are returned to the Dental Board Fund.

* Traditionally, the Dental Board's cash flow is at its lowest point in the spring. Due to the sweeps in recent years, the balance in the Dental Board Fund was less than the appropriated balance in March, April and May 2010 which prohibited expending as appropriated. The impact was experienced not only in halting operational improvements, but in facilitating the Board's Mission Statement of protecting the public.

VI. LEGISLATIVE ISSUES

The following changes to the Dental Practice Act became effective during FY11:

STATUTES

Arizona Revised Statutes (A.R.S.) § 32-1203(A) Dental Board; qualifications of members; terms:

- Changed the make-up of the Board by eliminating a public member and adding a business entity member.

A.R.S. § 32-1263.03 Executive Director; complaints; dismissal; review

- If delegated by the Board, the Executive Director, with concurrence of the Board's Investigative Staff, may terminate a complaint if the investigative staff's review indicates the complaint is without merit and that termination is appropriate.
- The Executive Director may not terminate a complaint if a court has entered a medical malpractice judgment against the licensee.
- The Executive director shall provide a list of complaints terminated at each regularly scheduled Board Meeting.
- The Termination may be appealed by the complainant. The appeals to be reviewed by the Board with possible action of approve, modify or reject.

A.R.S. § 32-1207 Powers and duties; fees; definition

- Records of adjudicated complaints are available to the Board at all times.
- If a case is dismissed or terminated, the record of the complaint shall not be available to the public
- If non-disciplinary action was taken, the record of the complaint shall be available to the public for five years

A.R.S. § 32-1289 Employment of dental hygienist by public agency, institution or school; definitions

- (F)(7) to read: A requirement that the patient be informed that the dental hygienist providing the care is a licensed dental hygienist and that the care does not take the place of a diagnosis or treatment plan by a dentist.
- (J) to read: Subject to the terms of the written affiliated practice agreement entered into between a dentist and a dental hygienist, a dental hygienist may perform all dental hygiene procedures authorized by this chapter except for the procedures identified in section 32-1281, subsection B, paragraphs 4, 5 and 6 or any diagnostic procedures that are required to be performed by a dentist.

STATUTES Not within the Dental Practice Act, but affect licensees

A.R.S. § 32-3213 Board actions; records; website; compliance deadline

- If a health profession regulatory board dismisses a complaint, the record of the complaint may not appear on the board's website.
- If a health profession regulatory board issues a non-disciplinary order or action, the record of non-disciplinary is available to that Board and the Public but may not appear on the Board's website.
- Must comply on or before January 1, 2012

HB 2472 Mobile Dentistry Units died in committee.

RULES

House Bill 2260 continued rulemaking moratorium through FY11.
